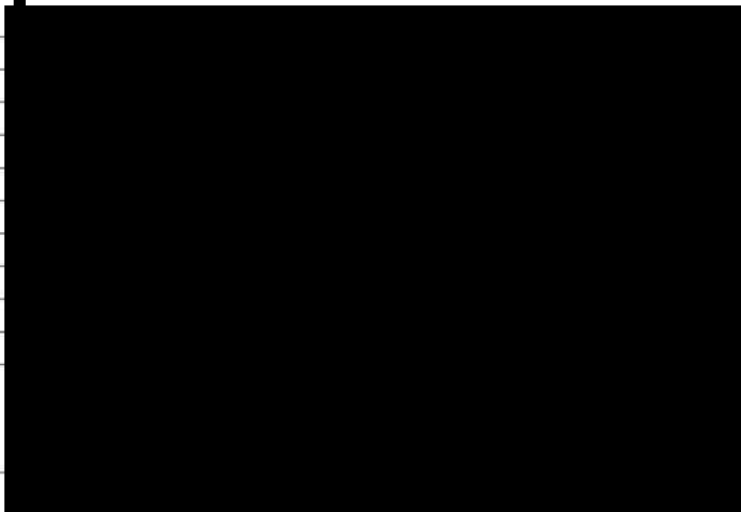

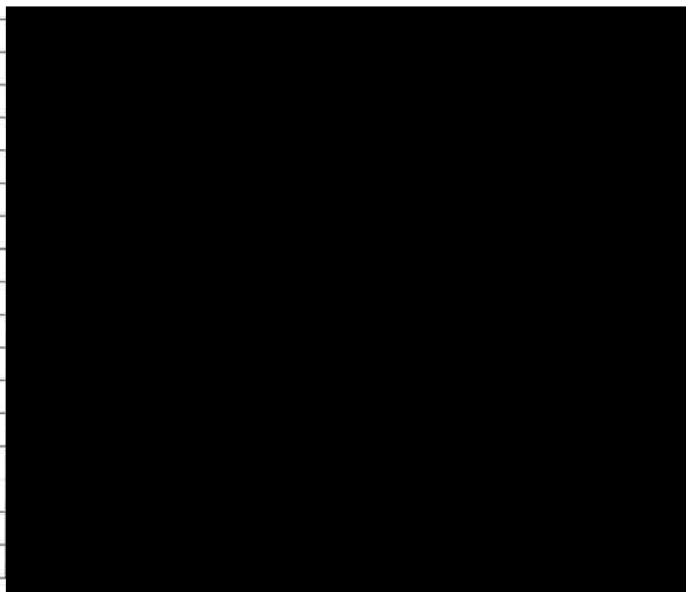

## Narrative

In summary, [REDACTED] (DL) was stopped for a minor traffic violation (TU-182-920) and was observed getting into a verbal altercation with an OEMC traffic aid. OEMC was detailed to Lollapalooza on Michigan Avenue and certain directions were closed off due to high pedestrian traffic. Theo Wilson did not adhere to what the Traffic Aid was saying and committed a traffic violation then sped off screeching his tires northbound onto Michigan Avenue from Monroe. R/O pulled over subject and an investigative alert revealed that he is a registered gun offender and to do an information report anytime an officer comes into contact with him. [REDACTED] was highly agitated and this is a BWC recorded incident. [REDACTED] also stated "get the fuck out of my way" directed towards r/o's partner. Wilson attempted to instigate a problem with police by turning up his music volume so that guard officer could not speak with him then stated "fuck you" towards guard officer. When asked to sign ticket he refused at first but later complied. Wilson sped off once stop was completed.
