him again to stop resisting. Again refused, and PO Hayes applied an open hand stun to the right
which time, PO Hayes placed in a wrist lock removing his right hand from the gear shift and ordered

In a To-From Subject Report, Accused Officer Timothy J. Hayes #7308, essentially related the same information as his partner, PO Dowling. He further related that was an active resister, whose demeanor was of desperation and sheer panic. PO Hayes added that when PO Dowling applied a wristlock to flailed his arms and tried to free himself, thus resulting in PO Dowling being sandwiched between the open car door and the vehicle being placed in reverse. PO Hayes that when he jumped halfway into the passenger's side vehicle, he landed on the passenger, in an attempt to prevent from continuing to drive in reverse. PO Hayes denied the allegations against him and denied observing the allegations made against PO Dowling. (Att. 30).

### Conclusion:

The R/I recommends a finding of Not Sustained for Allegation #1 that PO Dowling grabbed him by his throat. PO Dowling denied the allegation, however complained to hospital personnel of having shortness of breath and trouble swallowing. Furthermore, Inv. Kamalick noted that he observed redness and puffiness to the left side of throat. Therefore, there is insufficient evidence to prove or disprove the allegation. The R/I recommends of finding of Not Sustained for Allegation #2 that PO Dowling held him by his throat while PO Hayes punched him. PO Dowling denied the allegation. PO Hayes admitted to giving an open hand stun to Therefore, there is not enough evidence to refute or prove the allegation. The R/I recommends a finding of Unfounded for Allegation #3 that PO Dowling planted narcotics on has had numerous narcotic related arrests. Furthermore, in his ET and mug shot photos to having been under the influence of alcohol or drugs. The R/I recommends a finding of Exonerated for Allegation #4 in that PO Dowling twisted and bent his wrist. PO Dowling admitted using a wristlock technique on and there is nothing wrong with an officer using this technique to place an offender under arrest. admitted to having resisted and wrestled with the officers during his arrest.

The R/I recommends a finding of Unfounded for Allegation #1 that PO Hayes repeatedly punched about the face and head. PO Hayes denied the allegation. Furthermore, Inv. Kamalick noted that he observed an outward bulge to cheek, and swelling to the outside of his right eye. Hospital records indicated that was diagnosed as having a hematoma of the right lower eyelid. However, admitted to having resisted and wrestled with the officers during his arrest, thus some of the injury to his face was most likely caused when he resisted and wrestled with the officers, and not as a result of passive action.
