You have requested a large number of records spanning more than three years, some of which are not maintained directly by the district. Additionally, most of the records will require a review and many may require manual redaction. We will redact information which is confidential by federal law or falls within the predetermined categories outlined by the Texas Attorney General (See Open Records Decision Nos. 563 at 8 (1990)). Manual redaction of electronic records requires us to print copies of the information for the process. 

The Office of the Attorney General ("OAG") received the enclosed complaint from Lourdes Roldan alleging City of Corpus Christi (the "city") is overcharging for copies of public information under the Public Information Act (the "Act"), chapter 552 of the Government Code. The complaint was assigned ID# OR-23-000298-CC (Request 723).

The city received a request for text messages and phone logs for a named employee for specified dates. The city provided the requestor an estimate in the amount of \$472.25. The requestor believes the charges are excessive.

On May 10, 2023, the City of Corpus Christi (the "City") received the enclosed letter pertaining to a complaint filed with the Office of the Attorney General of Texas (the "Attorney General"), alleging that the City is overcharging for copies of public information under the Public Information Act (the "Act"). The City determined the number of personnel hours required to reproduce the responsive material by contacting the individuals whose cell phone text messages and call logs were requested. *See* **Exhibit D**. This inquiry revealed for just one individual there were 62 separate text conversations and numerous call log entries and through discussions with these individuals, it was determined that it would take 200 hours for these individuals to locate, screenshot, export, and save these text messages and call log entries before review. The labor was calculated as such:

Every text message and call log entry on the phone for three separate individuals per the search query within a 14 month time period. A conservative estimate of 200 hours to scroll through, allow the phone to load, and screenshot every single text message and call log entry on each of three separate phones charged at a rate of \$18.25 per hour resulted in a cost assessed to the Requestor for personnel labor in the amount of \$3,750.

In accordance with the costing provisions of the Act and rules established by the Attorney General, an overhead fee (calculated at 25% of the labor charge), was added to the total amount due. The overhead charged was \$937.50.

The text messages and call logs sought exist only in electronic form. To digitally redact, the text messages would need to be saved/converted to .pdf format and digitally redacted using the Adobe software. The redacted .pdf would then be provided to the requestor.

The records exist on the cellular phones of three city employees and may be found wherever those employees may be found.

Please state which exceptions to disclosure apply and if the city plans to seek a ruling for the requested information.

Yes. The City will redact dates of birth, account access numbers, and other information made confidential by law from the responsive material pursuant to previous determinations maintained by the City and as allowed by sections 552.101, 552.130, 552.136, and 552.137 of the Act which do not require the necessity of seeking an Attorney General ruling. The City will perform these redactions electronically to maximize time efficiency, and by extension, reduce the cost to the Requestor. Furthermore, as the City does not have the capability of directly redacting within the text message program or the photo screen shots of the texts, text messages requiring redaction will all be converted to .pdf format and redacted using the Adobe program.

On May 9, 2023, within 10 business days of receiving the original request, the Legal Department informed the requestor, via email, that a cost bond would need to be posted in the amount of \$117.19 in order to process their request. *See* Exhibit C.

At the time of receiving this complaint, the requestor has not posted the Cost Bond. As a preliminary matter, it should be noted that the City has not *charged* Mr. Weber any amount. To date, only an estimate has been provided which has not been paid. No charge has actually occurred. As such, the City would like to state that this complaint and the questions presented are premature because Tex. Govt Code 552.269(a) limits

complaints to the Attorney General to "overcharges", not mere estimates.<sup>1</sup> Without waiving this argument, the City is voluntarily responding to the Attorney General's questions out of a good will attempt to cooperate.

The City determined the number of personnel hours required to reproduce the responsive material by evaluating the request in detail and comparing it to previous requests processed by the City. The City evaluated the amount of time that particular past requests have required and also considered the nature of the types/frequency of email and text message correspondence typically exhibited for similarly situated individuals and employees. Additionally, the City reached out to staff members for affected areas for additional information regarding possibly responsive text messages to aid in estimating the amount of time collection of this data would require.

Further, to create a comprehensive, tailored time/cost estimate for gathering, reviewing, and sorting the generated emails to determine responsive, nonresponsive, confidential, and redactable information, a sample test was run which required programming all of the steps listed below in response to question number 2. Next, after programming of all of the steps below was performed, the individual performing the sample test evaluated the full sum of emails generated by the Microsoft Purview system. Then, this individual analyzed the content of a randomly selected representative subset portion of these emails to estimate the nature of the content of the entirety of the emails generated by the Microsoft Purview system and extrapolated these findings and applied these findings to the entirety of the full set of emails to determine the estimate of the hours that would be required for review, redaction, and evaluation of the emails that

would be required prior to release and/or submission to the Attorney General.

Additionally, an estimation was formed for the time to locate, compile, export, save, review, sort for confidentiality, sort for Attorney General submission and review, and sort for responsiveness/non-responsiveness, for all text messages that were sent and/or received during the time range in question. The time that will be needed to gather this information includes time it is estimated to access the cellular device, locate, screenshot, export, and save these text messages and call log entries before review. Depending on the quantity of messages/content existing on these devices, it may be necessary to scroll through several phone screens of data and allow the phone to load in order to sequentially screenshot every single text message. If the process is interrupted and must be restarted, the already captured messages must again be scrolled past on the phone in order to observe and capture earlier information. This process must be restarted every time the process is paused, if the text message application is exited, if the phone dies, if an incoming phone call comes into the phone, just as a few examples of things that can cause the process to need to be restarted. At times, seemingly without explanation, the phone will "jump" down to the most recent content in the conversation, and at this time the scrolling process must begin again anew in order to physically access and view the next screen of messages to capture.

- 2. How did the city determine the number of programming hours necessary to produce the responsive information? Please describe the programming in a step-by-step manner, stating the time each step will take as well as the qualifications of the individual performing the programming.
  - a. Interpret request and begin the necessary actions to fulfill request.
  - b. Once the request is established to be asking for an email search, a sample test is executed to determine the amount of responsive information. The steps for the sample test are as follows:
    - i. Boot up computer and Microsoft Purview system.
    - ii. Program the search parameters into Microsoft Purview system. Including:
      - 1. Program the name of the search and a description within the system. (2.5 minutes)
      - 2. Program the locations to which the search will be conducted (Exchange mailboxes, SharePoint sites, Exchange public folders, etc.) (2.5 minutes)
      - 3. Program the target user's mailbox to be searched. (10 minutes)

- 4. Program the date range into the search query (03-21-2023 to 04-18-2023). (2.5 minutes)
- 5. Program the participant mailboxes into the search query. (5 minutes)
- 6. Submit the search to be finalized. (5 minutes)
- 7. Once the search is finalized, the export output options are programmed. (10 minutes)
- Program Microsoft Purview to export Exchange content into one .pst file containing all messages in a single folder. (2.5 minutes)
- 9. Program the de-duplication of Exchange content to be enabled. (2.5 minutes)
- 10. Program the export to be executed. A job is then created. (10 minutes)
- 11. Copy the export key to clipboard. (2.5 minutes)
- 12. Program the export results to be downloaded. (10 minutes)
- 13. Open Microsoft.Office.Client.Discovery.UnifiedExportToo.a pplication from complianceclientsdf.blob.core.windows.net.(10 minutes)
- 14. Paste the export key (used to connect to the source) within the eDiscovery Export Tool. (2.5 minutes)
- 15. Program eDiscovery Export Tool to select the location that will be used to store downloaded files. (5 minutes)
- 16. Program the Export Tool to alter the .pst file name to be consistent with that of the request. (2.5 minutes)
- 17. Program the export to begin finalization and begin downloading. (10 minutes) (When using Microsoft Purview, the rate of a successful search/export are roughly at 50%. If either the search or export is unsuccessful, steps 1-17 must be repeated). (Total programming time of steps 1-17 is estimated to be 95 minutes)
- 18. If the export is determined to be successful, the programmer then navigates to Microsoft Outlook and selects "Open Outlook Data File" within the file tab.
- 19. The relevant .pst file is selected to be opened.
- c. Once the .pst file is opened within Microsoft Outlook, the sample test may be conducted.
- d. The number of produced emails/items are analyzed. The total number of produced emails/items help the programmer to anticipate how long the fulfillment of this request will take, using the completion of previous requests as a reference.

- e. If the produced emails/items are determined to have confidential information, an additional sample test is conducted to determine the amount of time that the programmer will need to perform electronic redactions.
- f. Once the emails/items have been analyzed/categorized, the programmer will then export the responsive emails/items into File Explorer.
- g. The emails/items are then transported onto a physical disc that may be provided to the requestor.

The individuals performing the programming have bachelor's degrees from accredited four-year universities and extensive training in the Microsoft suite of programs and the proprietary Microsoft Purview program. Attorneys who assist have doctorates of jurisprudence and other extensive training.

#### 3. Does the information requested exist in paper form, electronic form, or both? Please explain which records exist in paper form, and which exist in electronic form.

Neither emails nor text messages are physically stored or accessible via tangible means at City Hall unless they are printed. Emails are not stored in a location accessible by all employees. The Microsoft Purview program is a limited access program for which particular employees are granted a license to use on a limited basis. All of these records are only accessible in electronic form.

Text messages are only available in electronic form on privately owned devices and are not archived, backed up, or saved by the City or at City Hall. Rather, the electronic information, as potentially accessible to the Legal Department, solely exists on employees' personally owned phones. The City does not own or have access to any third party programs or software for automatic backing up or saving of text messages or any other type of cellular phone device data or information. This information is only accessible while physically possessing the cellular phone device with any access codes logged into/removed by the operator of the phone.

#### 4. Where are the records physically located? If the records are in two or more separate buildings, please provide a simple map showing the location of the buildings, including thoroughfares.

Emails are not stored in a location accessible by all employees. Emails are stored at City Hall in a server rack or on a hard drive there. See map below of City Hall's location in downtown Corpus Christi, Texas.





The Microsoft Purview program is a limited access program for which particular employees are granted a license to use on a limited basis. Backup server space is allotted for remote backup of information at an undisclosed safety-sensitive location. There is an additional secondary safety-sensitive backup location for the primary backup system which is located over 100 miles from City Hall, and the precise location of this backup system is not known to the majority of city employees, nor is the location known to the attorney writing this response letter.

Likewise, there are no physical text message records in the building or elsewhere. The messages exist solely on employees' privately owned phones and are available only upon meeting with the employee to access their cell phone device with their presence, permission, and typing in of access codes to allow viewing of their text messages. Going through the phone to physically capture screen shots of each text message is the only means by which the City of Corpus Christi has the technology to capture a record of any text messages.

5. Will any information be redacted from the records? If so, what information will be redacted, and will the redaction be done manually, electronically, or a combination of both? Please state which exceptions to

## disclosure apply and if the city plans to seek a ruling for the requested information.

Upon payment of the cost estimate, the City will perform a full review of the documents and program the redactable confidential information into the redaction software to apply the redactions. The City will redact dates of birth, account access numbers, and other information made confidential by law from the responsive material pursuant to previous determinations maintained by the City and as allowed by Texas Government Code §§552.101, 552.130, 552.136, and 552.137 and other applicable sections of the Act. The City will perform these redactions electronically to maximize time efficiency, and by extension, reduce the cost to the Requestor. Furthermore, as the City does not have the capability of directly redacting within the text message program or the photo screen shots of the texts, text messages requiring redaction will all first be converted to .pdf format and redacted using the Adobe program.

The Office of the Attorney General ("OAG") received a complaint from John Weber alleging the City of Corpus Christi (the "city") is overcharging for copies of public information under the Public Information Act (the "Act"), chapter 552 of the Government Code. The complaint was assigned ID# OR-23-000384-CC.

The city received a request for e-mail communications and text messages between two named individuals during a defined period of time. The city provided the requestor an estimate in the amount of \$117.19. The requestor believes the charges are excessive.

I tried to attach further documentation to each of these complaints but was not able to online. That is why I am sending this letter. I would like the enclosed to be attached to each of these complaints for consideration. The enclosed cost estimate was from prior PIA requests I had paid for. It was for 5 requests over a 14-month time span and 1 request over a 1-week time span. The city had 7 requests listed but 1 was a duplicate. The cost request was provided by Daniel De Leon, an experienced cost estimator at the city. The total locating hours were 2 and the total programming hours were 1.5. Please use these times when comparing the new cost estimates.

I would also like to point out that on every request that I filed that is associated with each of the complaints above I ask to inspect them. From the PIA Handbook it states: "usually the governmental body may not impose a charge" (for inspection only requests). And "overhead is not allowed on request for inspection of electronic records". I would prefer to inspect the records at the city office instead of picking up a CD.

On complaint OR-23-000384. I submitted the exact same request to the Port of Corpus Christi. They complied in 8 business days without any cost to me. They emailed me all the records.

It appears to me the city is charging me more now than they had in the past. It could be because of a newer inexperienced cost estimator or another reason. Either way, the cost estimates have gone up considerably since the one I paid for in March. It also seems on that one I was overcharged as well because there was an "overhead charge" for a "request for inspection of electronic records."

I appreciate your review and consideration of the enclosed documents.

I tried to attach further documentation to each of these complaints but was not able to online. That is why I am sending this letter. I would like the enclosed to be attached to each of these complaints for consideration. The enclosed cost estimate was from prior PIA requests I had paid for. It was for 5 requests over a 14-month time span and 1 request over a 1-week time span. The city had 7 requests listed but 1 was a duplicate. The cost request was provided by Daniel De Leon, an experienced cost estimator at the city. The total locating hours were 2 and the total programming hours were 1.5. Please use these times when comparing the new cost estimates.

I would also like to point out that on every request that I filed that is associated with each of the complaints above I ask to inspect them. From the PIA Handbook it states: "usually the governmental body may not impose a charge" (for inspection only requests). And "overhead is not allowed on request for inspection of electronic records". I would prefer to inspect the records at the city office instead of picking up a CD.

On complaint OR-23-000384. I submitted the exact same request to the Port of Corpus Christi. They complied in 8 business days without any cost to me. They emailed me all the records.

It appears to me the city is charging me more now than they had in the past. It could be because of a newer inexperienced cost estimator or another reason. Either way, the cost estimates have gone up considerably since the one I paid for in March. It also seems on that one I was overcharged as well because there was an "overhead charge" for a "request for inspection of electronic records."

I appreciate your review and consideration of the enclosed documents.



And to tell me the cost is more substantial even if I have it narrowed down worries me that if I narrow the request down you will demand more money stating the process will be even more difficult and time consuming. The real statement here is that the city is choosing to charge the amount stated. Texas law allows cities to provide the information I requested for inspection if it is deemed by the entity the city to be beneficial to release for the common good of the citizens. Who do I have to talk to that can make such a judgment call? If your unwilling to work with me at all as it seems now then I am left at reporting this to the Texas Attorney Generals office in a complaint that an overcharge for public records is occurring, and the city is clearly contradictory in their statements on cost. Also if you can not answer the following in some reasonable detail :

What is your criteria in determining whether or not records being released for inspection at no cost will benefit the public or not?

If you just give me a generic answer and rubber stamp a response then I am reporting the city of Denton records department to the state of Texas Secretary of State in a complaint form for abuse of official capacity and for official oppression. My request asked for a trimmed down cost making sense asking for less information and a bill of data to be excluded. Now I am requesting the city release the information for inspection at no cost as it's beneficial for the public to review the information that the community improvement services director and director of fair housing is communicating within the office and out to the public. I could elaborate more but I want a review for the information request to be provided to the public for inspection at no cost. I have the names and contact information of other citizens who want to review the information as well.



This office represents the City of Denton ("City"). The City is in receipt of your letter dated June 28, 2023, regarding a complaint filed by Joseph Welch (our file number C000402-032823) for charges associated with copies of public information under Public Information Act ("Act"), Chapter 552 of the Government Code. This letter follows your requirement the City respond within 10 business days to your letter.

The City (City Secretary's Office) utilizes the Cost Estimate Model from the Texas Attorney General's website each time an estimate is necessary.

1 T.A.C. Section 70.8(b) requires that a complaint must be filed with the Attorney General within 10 business days after the requestor knows of the alleged overcharge. On April 5, 2023, the City informed the requestor his request was voluminous and contained over 23,000 items. His response was received on April 8, 2023, to please prepare the cost estimate for the items he requested. The cost estimate was provided to the requestor on April 14, 2023.

The City did not receive a copy of the requestor's complaint sent to the Attorney General. However, on June 1, 2023, the requestor messaged the City indicating he filed a complaint "yesterday" meaning May 31, 2023. There were 32 business days from April 14<sup>th</sup> to May 31<sup>st</sup> when the requestor filed a complaint with your office. May 31<sup>st</sup> is past the 10-day deadline required under Section 70.8 (b) for the requestor to submit a complaint. The City requests this complaint be dismissed based on failure to comply with Section 70.8 (b).

The Office of the Attorney General ("OAG") received a complaint from John Weber alleging the City of Corpus Christi (the "city") is overcharging for inspection of public information under the Public Information Act (the "Act"), chapter 552 of the Government Code. The complaint was assigned ID# OR-23-000431-CC.

The city received a request for e-mail communications and text messages between two named individuals during a defined period of time. The city provided the requestor an estimate in the amount of \$319.38 to inspect the requested information. The requestor believes the charges are excessive.

Pursuant to section 552.269(a) of the Government Code, the city is required to respond to the following questions in writing within ten business days after the date you receive this letter:

1. How did the city determine the number of personnel hours necessary to produce the responsive information? Please describe the process in a stepby-step manner, stating the time each step will take. If a sample test was performed, please provide a brief description of the results of the test.

I tried to attach further documentation to each of these complaints but was not able to online. That is why I am sending this letter. I would like the enclosed to be attached to each of these complaints for consideration. The enclosed cost estimate was from prior PIA requests I had paid for. It was for 5 requests over a 14-month time span and 1 request over a 1-week time span. The city had 7 requests listed but 1 was a duplicate. The cost request was provided by Daniel De Leon, an experienced cost estimator at the city. The total locating hours were 2 and the total programming hours were 1.5. Please use these times when comparing the new cost estimates.

I would also like to point out that on every request that I filed that is associated with each of the complaints above I ask to inspect them. From the PIA Handbook it states: "usually the governmental body may not impose a charge" (for inspection only requests). And "overhead is not allowed on request for inspection of electronic records". I would prefer to inspect the records at the city office instead of picking up a CD.

On complaint OR-23-000384. I submitted the exact same request to the Port of Corpus Christi. They complied in 8 business days without any cost to me. They emailed me all the records.

It appears to me the city is charging me more now than they had in the past. It could be because of a newer inexperienced cost estimator or another reason. Either way, the cost estimates have gone up considerably since the one I paid for in March. It also seems on that one I was overcharged as well because there was an "overhead charge" for a "request for inspection of electronic records."

I appreciate your review and consideration of the enclosed documents.

Dear Mr. O'Bryan:

This letter is in reference to the public information request ("Request") submitted by you under the Texas Public Information Act ("Act"), Chapter 552, Government Code. The City of Pilot Point ("City") received your Request on October 6, 2022, in which you requested:

- 1. A copy of the text message between David Tatsak and me where I addressed his use of a racial slur and he acknowledged his use of it by replying to that text message.
- 2. Additionally, any and all written communications, emails, and/or text messages between the former police chief Tim Conner and Greg Wilkerson regarding Justin Hull. Greg's email account used would've been bluelinesvcs@gmail.com or alresources@gmail.com, and the time frame for the emails would've been approximately late 2018 into 2019.

In response to Item no. 1, the City has already provided this information to you and your attorney through previous discovery and open records requests. In response to Item no. 2, the City will be glad to make copies of the requested documents available to you along with any redactions or withholding of information authorized by the Texas Attorney General's Office. *The estimated costs to produce and copy all the records requested are as follows*:

In such an event, the City will send you a written updated itemized statement that details all estimated charges that will be imposed for providing copies of the requested public information, including allowable charges for labor or personnel costs. There is not a less costly way to review the requested information because your Request requires labor time associated with programming and manipulation of data allowed under Section 552.272 of the Act. Reducing the scope of your Request may reduce the costs associated with responding to your Request. Please contact me if you would like to reduce the scope of your Request. You will not be charged for the labor costs of an attorney conducting legal review of the documents to determine applicable Public Information Act exceptions.

Please be reminded that for purposes of Chapter 552, Subchapters F and G of the Act, a request for copies of public information is not considered to have been received by a governmental body until the governmental body receives the deposit for payment of anticipated costs. V.T.C.A. GOVERNMENT CODE § 552.263(e). The City is not required to send copies of the public information to you until you pay the postage and any other applicable charges, including deposits that have accrued under Chapter 552 of the Act. V.T.C.A. GOVERNMENT CODE § 552.221(b)(2).

Due to the amount of personnel time required to respond to your Request, we reasonably estimate that it will take ten business days to respond to your Request following receipt of the payment. Ten business days is reasonably necessary because the City will schedule an employee or agent to spend four hour(s) to program and manipulate the records responsive to your Request in lieu of performing their other designated job duties. Please be advised that the City has ten business days to seek an Attorney General determination as to whether the records you request are subject to disclosure under the Public Information Act.

Section 552.2615 of the Act imposes the following duties on you as the requestor of the concerned public information and requires that I inform you of these duties:

1. You must provide me with a mailing, facsimile transmission, or electronic mail address to receive the information requested. It is your choice as to which type of address to provide, however please be aware that some responsive documents may not be available in electronic format.

2. Your Request will be considered **automatically withdrawn** if you do not provide a **written** response, either by mail, in person, by facsimile or by electronic mail, to this itemized statement and any updated statement in the time and manner prescribed by Section 552.2615 of the Act. Section 552.2615 requires that you respond **within ten business days** after the date that this statement was sent to you. My address, facsimile number and email address are noted above on the letterhead. Your response must inform me that either: (1) you will accept the estimated charges; (2) that you are modifying your Request in response to the itemized statement; or (3) that you have sent to the Attorney General a complaint alleging that you have been overcharged for being provided with a copy of the requested information.

Section 552.2615 provides that an itemized statement or updated itemized statement will be considered to have been sent to you on the date that: (1) the statement is delivered to you in person; (2) on the date that it is deposited the properly addressed statement in the United States mail; or (3) on the date the statement is transmitted to you by electronic mail or facsimile transmission. V.T.C.A. GOVERNMENT CODE § 552.2615(e)(1)-(3). You will be considered to have responded to the itemized statement or updated itemized statement on the date that you: (1) deliver the response to me in person; (2) deposit the properly addressed response in the United States mail; or (3) the date that you transmit the properly addressed response to me by electronic mail or facsimile transmised.
