

**AMENDMENT FIVE
TO THE
CONTRACT FOR ACCESS AND VISITATION GRANT
BETWEEN
THE OFFICE OF THE ATTORNEY GENERAL OF THE STATE OF TEXAS
AND
HARRIS COUNTY**

OAG CONTRACT NO. 17-C0127

This Amendment Five to the Contract for Access and Visitation Grant ("Amendment Five") is entered by and between the Office of the Attorney General of the State of Texas ("OAG") and Harris County ("Contractor"). The OAG and the Contractor may be referred to in this Amendment Five individually as ("Party") and collectively as ("Parties"). The Parties to the Contract for Access and Visitation Grant, dated effective September 1, 2016 ("Contract"), now desire to amend the terms of the Contract and agree as follows:


1. Section 2.2, Contract Extension. The OAG has elected to extend the expiration date of the Contract for one (1) additional State Fiscal Year ("SFY"). The first renewal term commenced on September 1, 2017 and expired on August 31, 2018. The second renewal term commenced on September 1, 2018 and will expire on August 31, 2019. The third renewal term will commence on September 1, 2019 and will expire on August 31, 2020.
2. Section 4.1, The OAG's Maximum Liability. The maximum liability under the Contract increases to three hundred seventy-eight thousand nine hundred fifteen dollars (\$378,915). The Parties agree that the maximum liability for the third renewal term, SFY 2020 ("SFY20"), is eighty-eight thousand sixty-five dollars (\$88,065).
3. Section 4.2.1, Budget. The Contract amount will be allocated by SFY, subject to renewal and approval at the end of each SFY in accordance with Section 2.2. The budget categories and total amounts for the third renewal term of this Contract are provided in Table 1 below, and in Attachment C, *Detailed Program Budget*.
