AMENDMENT ONE TO THE

This Amendment One to the Contract for Access and Visitation Grant ("Amendment One") is entered by and between the Office of the Attorney General of the State of Texas ("OAG") and Harris County ("Contractor"), which are the parties to the Contract for Access and Visitation grant, dated effective September 1, 2016 (the "Contract"). The OAG and Contractor now desire to amend the terms of the Contract by increasing the maximum liability of the Fiscal Year 2017 term and agree as follows:

1. Section 4.1, The OAG's Maximum Liability, is replaced in its entirety by the following:

The maximum liability under the Contract for the Initial Term was \$60,000. The OAG and Contractor agree that the maximum liability of Fiscal Year 2017 is increased to \$90,000.

2. Section 4.2.1, Budget, is amended as follows (New text is underlined and removed text is stricken.):
