

**AMENDMENT THREE  
TO THE  
CONTRACT FOR ACCESS AND VISITATION GRANT  
BETWEEN  
THE OFFICE OF THE ATTORNEY GENERAL OF THE STATE OF TEXAS  
AND  
HARRIS COUNTY**

**OAG CONTRACT NO. 17-C0127**

This Amendment Three to the Contract for Access and Visitation Grant ("Amendment Three") is entered by and between the Office of the Attorney General of the State of Texas ("OAG") and Harris County ("Contractor"). The OAG and the Contractor may be referred to in this Amendment individually as (a "Party" and collectively as "Parties"). The Parties to the Contract for Access and Visitation grant, dated effective September 1, 2016 (the "Contract"), now desire to amend the terms of the Contract and agree as follows:

1. Section 2.2, Contract Extension. The OAG has elected to extend the expiration date of the Contract for an additional fiscal year. The First Renewal Term commenced on September 1, 2017 and will expire on August 31, 2018. The Second Renewal Term will commence on September 1, 2018 and expire on August 31, 2019.
2. Section 4.1, The OAG's Maximum Liability. The maximum liability under the Contract increases to \$296,000. The Parties agree that the maximum liability for the Second Renewal Term, Fiscal Year 2019, is \$103,000.
3. Section 4.2.1, Budget. Table 1 below and the Detailed Program Budget attached as Attachment C reflect the budget categories and amounts for the Second Renewal Term of this Contract (Fiscal Year 2019). For Renewal Terms, the 12-month Contract amount will be allocated by Fiscal Year, subject to renewal and approval at the end of each Fiscal Year in accordance with Section 2.2.
