



On November 1, 2021 I was instructed by Captain Zappolo to conduct an investigation regarding a note that was sent via
interoffice mail. The note was dated 10/28/2021 and it was sent by Inmate The note was
addressed to the PREA coordinator. In the note inmate leading that he made a PREA complaint on 9/27/2021
against Officer Samuel Wixon #409. Inmate further claims that he was sexually assaulted and that PREA
procedures were not followed. Inmate further claims that he was released two days after making the claims and
that he would now like them looked into now that he has returned to the facility. The claims made by Inmate were
in fact investigated by Sat. Erik Nehrkorn #135 on 9/26/2021. The actual incident with Officer Wixon took place on
9/25/2021. Inmate control original complaint was that on 9/25/2021 at approximately 1550 hours. Officer Wiyon
attempted to give him a fist bump and then touched him on the shoulder. Inmate also stated that Officer Wixon
"narassed" nim afterwards. Sgt.Nenrkorn conducted an extensive video review and did observe Inmate Wixon attempt to fist
bump Inmate no physical contact was made. During video review, Sqt. Nehrkorn also observed that Officer
Wixon did attempt to touch Inmate on the shoulder but Inmate noved away - no physical contact was
made. Sgt. Nehrkorn also observed that Officer Wixon and Inmate and Converse afterwards but could find no
evidence of harassment. Sgt. Nehrkorn spoke to Inmate about his findings that no physical contact was made.








I further explained that the footage also showed Officer Wixon attempt to touch you on the shoulder after you denied to give him a fist bump, and he did not make any physical contact then stated. "Yes you probably saw me dodge his hand with you. Inmate by moving my body". Inmate then stated, "I still want a grievance for him harrassing me". 

On November 1, 2021 I was instructed by Captain Zappolo to conduct an investigation regarding a note that was sent via
interoffice mail. The note was dated 10/28/2021 and it was sent by Inmate. The note was
addressed to the PREA coordinator. In the note Inmate claims that ne made a PREA complaint on 9/27/2021
against Officer Samuel Wixon #409. Inmate further claims that he was sexually assaulted and that PREA
procedures were not followed. Inmate further claims that he was released two days after making the claims and
that he would now like them looked into now that he has returned to the facility. The claims made by Inmate were
in fact investigated by Sqt. Erik Nehrkorn #135 on 9/26/2021. The actual incident with Officer Wixon took place on
9/25/2021. Inmate priginal complaint was that on 9/25/2021 at approximately 1550 hours, Officer Wixon
attempted to give limi a list purilp and then touched him on the shoulder. Inmate
"harassed" him afterwards. Sgt.Nehrkorn conducted an extensive video review and did observe Inmate Wixon attempt to fist
bump Inmate - no physical contact was made. During video review. Sqt. Nehrkorn also observed that Officer
Wixon did attempt to touch Inmate on the shoulder but Inmate moved away - no physical contact was
made. Sgt. Nehrkorn also observed that Officer Wixon and Inmate.
evidence of harassment. Sgt. Nehrkorn spoke to Inmate about his findings that no physical contact was made.
Inmate admitted that he dodged Officer Wixon's hand by moving his body. Inmate requested a
grievance for harassment and was issued grievance on 9/26/2021. Inmate was released on 9/28/2021
and then returned on 10/21/2021. I reviewed the DVR footage of the incident. I then interviewed Inmate
11/1/2021 at 2105 hours in the Bravo housing center. Inmate claimed that Officer Wixon tried to fist bump him
and then grabbed his shoulder after he was unsuccessful. I told Inmate lease that this issue was reviewed and that he
was never touched by Officer Wixon. Inmate the second replied that he doesn't feel safe here and that he wants a staff no
contact with Officer Wixon. Inmate an area returned to without further incident. I find the claims made by Inmate.
to be unfounded. A copy of the grievance report, note submitted by Inmate and DVR footage was
submitted with this memo. End of memo.



I further explained that the footage also showed Officer Wixon attempt to touch you on the shoulder after you denied to give him a fist bump, and he did not make any physical contact then stated, "Yes you probably saw me dodge his hand with you. Inmate by moving my body". Inmate the stated, "I still want a grievance for him harrassing me". Upon further review of the DVR footage from that incident I did see Officer Wixon attempt to engage in a conversation with Inmate on his next round in the unit. Inmate was issued arievance staff.
