On Tuesday April 09, 2019, I conducted an interview with Inmate and an investigation persuant to letters Administration received from and the New York State claims to be the mother of Inmate Commission of Correction. In her letter Ms. expresses concern for the safety of Inmate During the interview I first guestioned Inmate if he was concerned about his safety. Inmate and the relayed no safety concerns. Second, I questioned Inmate if he has had any recent contact with his mother that would be concerned about his safety. Inmate stated that he was being issued an Instant Adjudication on by Officer Byrnes, Kevin 310. Inmate further stated that he told his mother via inmate phone that he was being locked in and that if she did not hear from him to call and check on him. Inmate then laughed and said that he had forgotten to call her and that she was probably worried about him. I advised to call his mother and let her know that he was fine. Inmate did state that he Inmate currently has a Grievance against Officer Byrnes for discrimination. The Grievance was found to be without merit and fowarded to the Citizen's Policy and Complaint Review Council. Inmate also has another Grievance against staff that is open. In the grievance, Inmate makes no claims for concern of his safety, but does again claim discrimination. During the rest of the interview, Inmate nade no other complaints against staff, Medical, or Mental Health. Upon conclusion of the interview, I find Ms claims to be unfounded. 
