## MEMORANDUM

TO: Sheriff Carl E. DuBois

RE: New York State Commission of Corrections complaint 

Sir, the purpose of this memorandum is to report my findings of New York State Commission of Corrections complaint  Complaint  as mailed to New York State Corrections and Community Supervision by Inmate  on May 8th 2021 from the Orange County Correctional Facility, and subsequently forwarded to the New York State Commission of Correction on June 17th 2021. Complaint  as also mailed to New York State Corrections and Community Supervision by Inmate  from the Orange County Correctional Facility, and subsequently forwarded to the New York State Commission of Correction on May 21st 2021. Both complaints were then forwarded to Orange County Sheriff Carl E. DuBois for investigation. In Sum and Substance, Inmate  alleges that while incarcerated at the Orange County jail he has been "raped", "jumped" and "shot up with something" by Corrections Staff. This incident was previously investigated as a Prison Rape Elimination Act event. All facility protocols related to a PREA event were followed. The incident was properly investigated at the direction of PREA Coordinator Captain James Potter. The Orange County Correctional Facility retains written records of both incidents.

On April 21st 2021 Inmate  was escorted to the facility medical department for complaints of chest pain. During the evaluation, Inmate  advised Registered Nurse Adrienne Cupertino that he was sexually assaulted. Inmate  was subsequently transported to Garnett Health Medical Center for further evaluation. The incident was referred to Orange County Sheriff's investigator Timothy Riorden for further investigation. The allegation was thoroughly investigated and found to be without merit. The hospital medical report indicates no signs of trauma and a diagnosis of schizophrenia with a lack of insight into his own illness. Additionally, Inmate  made a second PREA related complaint on May 20th, 2021. On the date of complaint Inmate  was escorted to the facility medical department and evaluated by Registered Nurse Tasha Juracek. Inmate  was then transported to Garnett Health Medical Center for further evaluation. The incident was referred to Orange County Sheriff's investigator Timothy Riorden for further investigation. The allegation was thoroughly investigated and found to be without merit. The hospital medical report indicates no physical abnormalities and that Inmate  exhibited signs of antisocial personality disorder. Orange County Sheriffs case  are attached to memorandum for review.

Subsequent to both allegations, Inmate [REDACTED] was placed on constant supervision to document his interactions with staff and initiate continued Mental Health care. Inmate [REDACTED] has remained under constant supervision to date. After extended Mental Health evaluations and care, facility Mental Health Wellpath has determined that Inmate [REDACTED] be committed to the custody of a psychiatric hospital to receive medical diagnosis and treatment under Section 508 of the New York State Correction Law. At the time of authoring of this memorandum Inmate [REDACTED] is awaiting placement into such facility. Inmate [REDACTED] will remain under constant supervision until which time he is removed from the facility. The constant supervision is inclusive of constant video recording when appropriate to prevent any further allegation of sexual assault or abuse in any form. In conclusion, I find that the complaint made by Inmate [REDACTED] is unfounded. The allegations made by Inmate [REDACTED] have been investigated several times and found to be without merit. I find it appropriate to conclude that Inmate [REDACTED] altered mental health status have contributed to the false allegations made.

04/21/2021 18:34 -- CROWN, TIMOTHY (8919) -- On April 21, 2021, at approximately 1754 hours, I responded to the [REDACTED] Housing Unit in the Orange County Jail to attempt to follow up with [REDACTED] regarding sexual allegations to which [REDACTED] was the victim. I was escorted to the unit by Corrections Sgt. Figueroa. I asked whether [REDACTED] would be able to be taken out of his cell so a statement could be obtained. I was advised by Sgt. Figueroa that [REDACTED] could not be removed from his cell at this time due to him being a flight risk. I was advised that [REDACTED] and I attempted to speak with him through the door.

Upon making contact with [REDACTED] at his cell door, I advised him of the purpose of me being there. I asked him whether he would be willing to talk to me about the sexual allegations he has made. Initially, [REDACTED] agreed to speak with me. While trying to speak with [REDACTED] it was clear that he was mentally unstable. [REDACTED] was incoherent and his thoughts were completely unorganized. After stating I wanted to speak with him specifically about the sexual allegations he made, he went on to talk about his food and how the food he is being giving is not kosher and he is supposed to be on a kosher diet. I advised him that I understand he is upset over his food, but the reason I was there was to obtain information about the sexual allegations he made. [REDACTED] then stated that he wanted to show me something and stated he had evidence of sexual assaults. He walked over to his bed area and grabbed a half of sandwich wrapped in saran wrap and stated it was DNA evidence. I attempted to have [REDACTED] elaborate, but he continued to be incoherent and began talking about how corrections officers let people into his cell. [REDACTED] then stated on April 13, 2021, while in the Bravo 1 Housing Unit of the jail, corrections officers let civilians in to his cell and these civilians sexually harassed him. [REDACTED] stated that he did not know the names of the individuals who sexual harassed him on the thirteenth, but stated that "they are here right now," in his cell. [REDACTED] was alone in his cell during the interview. He then went on to say that I could not see the people in the cell due to digital technology. [REDACTED] stated the people in his cell wear vest and invisible cloaks. [REDACTED] stated that corrections staff lets these people into his cell and these people sexually assault him. [REDACTED] stated that these people touch him and tell him things like they want him to eat their semen. [REDACTED] then went on to say on April 14 and 15, 2021, between the hours of 1700 and 1900, the jail ERT team went into his cell and cut his jail jumper open with a knife, injected him with a needle and then sexually assaulted them. While [REDACTED] was telling me about the sexual allegations, he continuously went back to the subject of his food. He opened his food tray multiple times and had me look at it. I inspected his food through the cell door and I did not notice any issues with it. I tried multiple times to keep [REDACTED] focused on the sexual assault but was unsuccessful. I attempted to get a statement from [REDACTED] but he began to be uncooperative while talking to me. He stated he did not want to talk to me through the door and wanted to talk in a room. [REDACTED] went on to state that he wanted a private investigator, lawyer, detective and federal authorities present while giving a statement.

I then spoke with Correction Sgt. Figueroa and Murphy and advised them that I was finished with my follow up. They told me about [REDACTED] previous behavior, which was consistent with the behavior he displayed while I was attempting to speak with him. Specifically, they stated that he always thinks that his food is being messed with and that people with invisible cloaks are in his room. I spoke with Corrections Lt. Weed prior to leaving the jail. Lt. Weed stated that they have put in multiple mental health slips for [REDACTED]. Moreover, Lt. Weed advised that in order to speak with [REDACTED] in an interview room, ERT would need to be involved. Sgt. Carpentier was advised of the status of my follow up.

I advised the Medical Unit that I was the Investigator assigned to investigate the possible PREA incident. I spoke with Registered Nurse Adreienne Cupertino(CUPERTINO). I was then informed that on April 21, 2021 at approximately 0955hours, [REDACTED] came to the Medical Unit complain of chest pain. I was advised that this is a common occurrence with [REDACTED]. During the exam [REDACTED] indicates that he is subject to use of force since he has been at the facility. [REDACTED] then goes on to say that he has been subject to sexual assaults today, yesterday and the day before ( these dates being April 19, 2021, April 20, 2021 and April 21, 2021) while confined in his cell. [REDACTED] was unable to provide specific details of the events but when asked by CUPERTINO if he sustained any injuries he replied that his anal cavity hurt. CUPERTINO did not assess the injury but reported the incident to the Orange County Jail PREA Coordinator Captain Potter [REDACTED] was then transported to Garnet Health Medical Center for an evaluation.

I was informed that He was with [REDACTED] at Garnet Health Medical Center. I advised NARCISE that I would like to make arrangements to interview [REDACTED] and to obtain the rape kit upon its completion to turn in to the Evidence Room. NARCISE then asked Garnet Health Medical Center Dr. Bloom when the exam would be completed. Dr. Bloom informed NARCISE that neither he nor Garnet Health Medical Staff will be completing a rape kit due to the fact that too much time has passed since the alleged sexual assault incident. I advised NARCISE that seems to be inaccurate due to the fact that Orange County Jail Medical Staff, Registered Nurse Adrienne Cupertino(CUPERTINO) informed me [REDACTED] told her he was sexual assaulted "Today, Yesterday and the day before." The dates would have been between April 19, 2021 and April 21, 2021. Dr. Bloom advised NARCISE that [REDACTED] told him the incident happened at least five days ago and didn't mention multiple occurrences. DR. Bloom was going to exam [REDACTED] for injuries however it was likely [REDACTED] was going to be discharged from the hospital very soon. As the exact time of discharge was uncertain, I provided this information to Sgt. Carpentier who assigned Deputy Crown to interview [REDACTED] at the Orange County Jail upon his return from the hospital.




Per the Orange County Jail incident reports, [REDACTED] became non compliant and refused to close his chow tray slot. [REDACTED] tried to keep the tray slot open with his hands and even used blankets to attempt to keep it open. Correction Officers were able to remove [REDACTED] from the cell#4 and transported him to Orange County Jail Medical. While at medical [REDACTED] stated that he does have Schizophrenia. the events, but when asked by CUPERTINO if he sustained any injuries he replied that his anal cavity hurt. CUPERTINO did not assess the injury but recommended that [REDACTED] be evaluated at Garnet Health Medical center. The incident was then reported to Orange County Jail PREA Coordinator Captain Potter. As a result of the allegation, it was determined that [REDACTED] would in fact be transported to Garnet Health Medical Center for further evaluation and to have a rape kit collected. As Orange County Jail Correction Officers were preparing [REDACTED] to be transported to Garnet Health Medical Center, [REDACTED] became non compliant. [REDACTED] had food items secured in his waistband wrapped in cellophane. [REDACTED] continually refused to turn these items over prior to transport. [REDACTED] was under belief that these various food items were evidence of sexual assault and some were even injected with bodily fluids. At approximately 1211hours [REDACTED] eventually complied with Correction Officers and was subsequently transported to Garnet Health Medical Center for further evaluation.

[REDACTED] arrived at Garnet Health Medical Center on April 21, 2021 at approximately 1308hours. [REDACTED] informed the Medical Staff that he was sexually assault four to five days ago. This contradicted the time frame that [REDACTED] told CUPERTINO in the Orange County Jail Medical Unit. As a result of the incident occurring approximately four to five days in the past, Garnet Health Center Medical Doctor Bloom(BLOOM) indicated a rape kit was not performed. As indicated by the Medical Report I later received. [REDACTED] was evaluated by BLOOM for trauma with negative findings. [REDACTED] was discharged from the hospital at 1727hours.

Upon [REDACTED] return to the Orange County Jail he was interviewed by Deputy Crown at approximately 1745hours. During the interview, [REDACTED] wanted to show Deputy Crown evidence of the sexual assaults. [REDACTED] walked over to his bed area and grabbed a half of sandwich wrapped in saran wrap and stated it was DNA evidence. Deputy Crown attempted to get [REDACTED] to elaborate, however [REDACTED] was incoherent and began talking about how corrections officers let people into his cell. [REDACTED] then stated to Deputy Crown that on on April 13, 2021, corrections officers let civilians in to his cell and these civilians sexually harassed him. [REDACTED] stated that he did not know the names of the individuals who sexual harassed him on the thirteenth, but stated that "They are here right now." in his cell. [REDACTED] was alone in his cell during the interview. [REDACTED] then went on to say that Deputy Crown could not see the people in the cell due to digital technology. On April 23, 2021 I sent a subpoena request to the Orange County District Attorney's Office to get a copy of [REDACTED] medical records from Garnet Health Medical Center on the date of his evaluation on April 21, 2021. I was advised by Sr. Assistant District Attorney Investigator Garcia to have [REDACTED] sign a medical release form for the incident. On April 26, 2021 [REDACTED] signed the Garnet Health Medical Center Release form. I received the medical documents and reviewed them in their entirety. The documents indicated that [REDACTED] is diagnosed with Schizophrenia. A rape kit was not performed however [REDACTED] was evaluated for trauma. Per the medical report, there was no sign of trauma to [REDACTED] anal cavity. It was indicated that during the Medical Evaluation, [REDACTED] informed the attending doctor that he was hearing voices and had suicidal and homicidal thoughts. The Medical report also indicated that [REDACTED] lacks insight into his illness. As there was no trauma, [REDACTED] was discharged and returned to the Orange County Jail. Per the Medical Report, [REDACTED] should be on a one on one suicide precaution until he is cleared by Orange County Jail Psychiatric Services. I advised Captain Potter of the the Doctor's findings pertaining to a one on one suicide watch. I also advised him of [REDACTED] mental health ideations.

I then reviewed all of the video from the Orange County Jail on the dates and times that [REDACTED] stated he could have been subject to sexual assault. I reviewed the videos that had the best view of the cell that [REDACTED] was housed in on the specific date in question. [REDACTED] was housed in numerous cells within the Delta 1 Housing Unit. [REDACTED] moved between [REDACTED] These are the following dates and times of the alleged sexual assault incidents, April 14, 2021 1700-1900, April 15, 2021 1700-1900, April 19, 2021 0300-0600, April 20, 2021 0300-0600, April 21, 2021 0300-0600. I reviewed all of these videos in their entirety. There was only one incident during these times frames involving [REDACTED] and that was on April 14, 2021 at approximately 1730hours. On this date, [REDACTED] became on non compliant inmate and refused to close his cnow tray slot. I watched the video as well as the handheld video of this entire incident.. At no time was [REDACTED] subject to any sort of sexual assault.

In conclusion, after review of the medical reports, the officers reports and the videos of the incidents, [REDACTED] was not subject to sexual assault. Case closed at this time.

I responded to Garnet Health Center, Room 29 and met with the victim [REDACTED]. Upon my arrival, I spoke with Officer KELLY #119 who stated that while the NYS assembly and Undersheriff Jones were making rounds [REDACTED] stated he was raped by jail staff. I spoke with [REDACTED] who stated that on 05/20/2021, at approximately 0900 hours, Orange County Jail staff came to his cell on [REDACTED] to bring him to the Sergeants area for mental health. [REDACTED] stated that while in the Sergeants area an unknown white male, approximately 6'00 tall, and muscular, stuck his penis into his rectum. [REDACTED] stated that a white female, named Jen. who works in mental health then spit into his rectum and stuck a dildo into his rectum. [REDACTED] stated that after they were done they brought him back to his cell and refused to provide him medical treatment. A rape kit was completed and sealed by RN Samantha KRUNFOL (KRUNFOL). KRUNFOL turned over the rape kit and clothing to myself at approximately 2228 hours. Evidence was transported back to OCSO and secured in lockers number 2 and 3. Evidence was turned over Deputy Durso to be placed into evidence. Case to continue.

My name is [REDACTED] and I give this statement voluntarily. On 05/20/2021, at approximately 0900 hours, Orange County Jail Staff came to my [REDACTED] Housing unit, to escort me to the Sergeants area for mental health. While in the Sergeants area, an unknown white Officer, approximately 6 feet tall, with a muscular build pulled his pants down and stuck his penis into my rectum. After that a short white female, that works in Mental Health, named Jen spit into my rectum and stuck a dildo into my rectum. 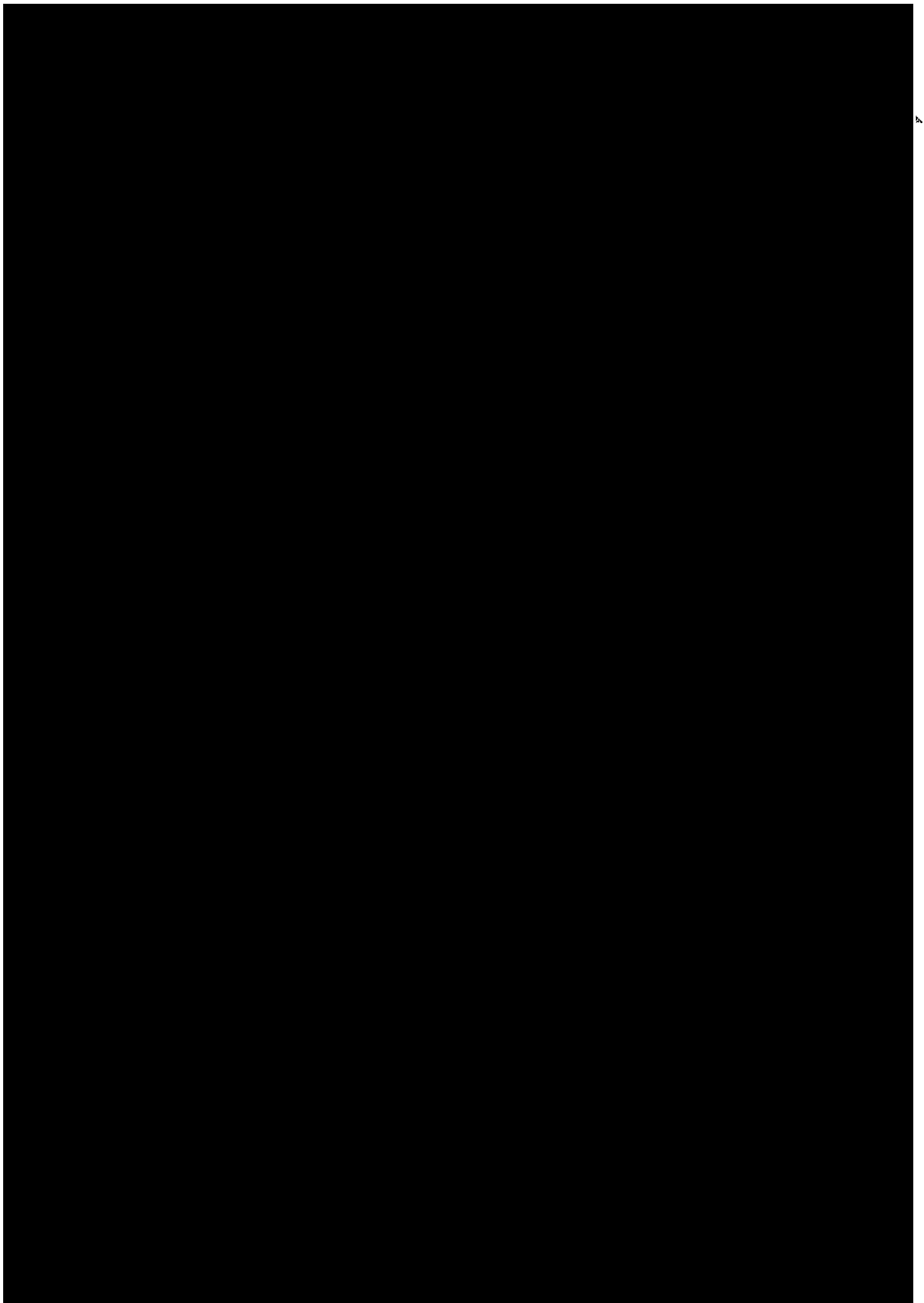

Room #4. [REDACTED] was shackled to the table during the interview and had his handcuffs removed. Correction Officers left the room and [REDACTED] was completed his mental health assessment with KRIEDER. Per KRIEDER, at no time did [REDACTED] make any statements about sexual assaults nor did KRIEDER make any physical or sexual contact with [REDACTED]. Additionally, there were no Correction Officers in the room during the mental health assessment during the assessment. The assessment ended at 0937hours and [REDACTED] was then escorted back to the [REDACTED] Housing Unit. [REDACTED] was video taped during the escorts by a handheld video camera. After reviewing the recording, at no time did I observe PEARSON be subject to sexual harassment nor did he mention anything in regard to the allegation during the escort.

After [REDACTED] made the allegation of being victim to sexual assault at 1912 hours, PEARSON was escorted to the Orange County Jail Medical Unit for assessment. While in the Medical Unit, [REDACTED] made statements he was sexually assault by a male and a female. [REDACTED] then left the Orange County Jail at 1937hours and was transported to Garnet Health Medical Center for sexual assault evaluation. [REDACTED] was evaluated by Medical Staff at Garnet Health Medical Center. After review of the Medical Records, the assessment stated that [REDACTED] has past psychiatric history of malingering and psychosis NOS. According to the medical report [REDACTED] appears to me malingering to get out of jail. His actions at the hospital were consistent with antisocial personality disorder. Nevertheless, [REDACTED] was evaluated for sexual assault trauma with negative findings. A rape kit was completed. [REDACTED] was then discharged from the hospital and returned to the Orange County Jail and was secured in his cell at approximately 2319hours.

While at Garnet Health Medical Center, [REDACTED] was interviewed by Deputy Burger. During the interview, [REDACTED] explained that on May 20, 2021 at approximately 0900 hours, Orange County Jail Staff went to his [REDACTED] located in the [REDACTED] Housing unit. He was then escorted to the Sergeants area for mental health. While in the Sergeants area, [REDACTED] claimed an unknown white Officer, approximately 6 feet tall, with a muscular build pulled his pants down and stuck his penis into his rectum. [REDACTED] then described that a short white female, that works in Mental Health, named Jen spit and stuck a dildo into his rectum.

I spoke to Inmate [REDACTED] regarding these allegations, and he stated to me that someone put a mob hit on him, that staff have raped him, and named Officer Kelly and Sergeant Figueroa as these officers that raped him. Inmate [REDACTED] was in fact sent out to Garnett Health Medical Center for evaluation for his rape claim. There are reports on file regarding these allegations with the PREA Coordinator Captain James Potter. Inmate [REDACTED] stated to me that he was shot up with something in his cell and that someone is putting stuff in his food. Inmate [REDACTED] was not speaking coherently or making any sense on any of these allegations. 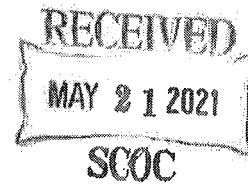


