On December 11, 2020, I completed an investigation persuant to a letter sent by Inmate to NYS Commission of Corrections. In the letter, Inmate alleges being assaulted by staff a number of times. Specifically, Inmate alleges being assaulted in January 2020; September 10, 2020; and October 5, 2020.
January 16, 2020, Inmate was involved in a Use of Force with staff. The incident was previously investigated and found to be justified and appropriate.
September 10, 2020, Inmate was involved in a Use of Force with staff. The incident was previously investigated and found to be justified and appropriate.
October 5, 2020, Inmate was involved in a Use of Force with staff. The incident was previously investigated and found to be justified and appropriate.
On December 11, 2020 I conducted an interview with Inmate In sum and substance, Inmate reiterates the information listed in his letter. I did specifically ask about the claim of Officers saying, "If you sue I don't lose anything I still have a job, home and money". I asked Inmate to give me names of Officers making that statement. The inmate refused to name anyone.
After reviewing the information in the prior incidents, including greivences submitted, I find Inmate allegations of being assaulted to be unsubstantiated. All of the incidents involve staff attempting to maintain control and prevent injury to inmate and staff as a result of Inmate actions. End Memorandum.



These incidents are on camara and I need to speak to Sometraly A.S.A.P herause they have prome worke this last time leaving me with a scar from my hair line to my eyebrow. In January while my hands were up on the west a sergent jumped on my back and applied a choke hold on sepolo while a' fight was going on upstairs on mu housing unit I was downstairs on ma door assiting to be locked down. First responders made a beetine for the fight the officers that come after came Straight for me even though again I had nothing to do with what's going on upstairs I got a ticket and touched for that incident and officers got yelled at because I wasnit supposed to be touched. The ticket written was to justify the Use of force and Since there was no

reason for me to be tax hed as as the camera will show it was a very touchy Situation with every Officer involved. This last assuall that accurred was actober 5th and while I was already on the graind restrained responding Est officers Continued to spray me grab me by my hair and bounce my head off the ground leading to the scar. I seriousia need to meet with some one to have these assualts looked into. I know you all are extremely Lusy especially during this pandemie but please I need to speak with Someone I have grieved all incidents and have lost them at the facility level appealed them to the col and was denied by him as well everything in house has been useless because officers have said and I quote" If upu sue I don't lose anothing I Still have a lob, flome and money".
