AXON "Citizen for Communities" link is available to put out so the public can start submitting video and pictures of looters. This program is very user friendly and allows citizens to remain anonymous. The program requires users to put their phone number(mandatory), this is to maintain the integrity of evidence for further prosecution, but does not require name or address.

Public will click on the link, fill out their number, and they will receive a private text from AXON. In that private text, it will include the "upload" option, allowing citizens to download the data.

We have attached screenshot pictures for you to see what the screen looks like. I have also included the link that you can put up on the website to let our community members know that it is active.

I have also included a brief description that you can put out through social media and other forms of communication.

We have also started an email address that community members can send information to related to the looters. Please use the following email, LBPDCrimeInfo@longbeach.gov

Dear Chief Luna,

I am asking for the de-escalation and de-militarization of the Long Beach Police Department. I am asking for a comprehensive and public internal review board, and oversight committee. I am asking for the Long Beach Police Department to reallocate funds for arming officers in riot gear and "less than lethal" weapons to de-escalation training, extreme vetting for police officers, and public reviews of all uses of force by the police department.

I am asking you to make a public comment on the state of fund allocation within the Long Beach Police Department. I am asking you to publicly condemn police brutality. I am asking you to say, unequivocally, that Black Lives Matter. I am asking you to say these things without hand-wringing or making conditional remarks on the "violence" caused by "looters." Hold the police within Long Beach, Los Angeles, California, and nationwide accountable for their actions -- including escalation, violence, and brutality.

Mayor Garcia once said to me that the LBPDP receives de-escalation training for use with individuals who have "mental health challenges." That does not cut it for me. De-escalation is a vital part of nonviolence and abstaining from uses of force. De-escalation should be the requisite first response from police in ALL cases.

Please, I am begging you to come forward and say that Black Lives Matter. To my knowledge, you have never said these words. Why is this suddenly a political issue? I can only assume that your lack of action -- even at the most basic level, to say three words -- is because you do not honor the lives of Black Americans.

Police Chief Luna, I applaud your restraint for not arresting and using force with looters. However, this is not enough. I need you to take a stand, here. I need you on the front lines of a protest. I need you to be unarmed, with your hands up, side by side with protestors. I need this from you, and the city of Long Beach needs this from you.
