She works with [REDACTED] and has been very active in local “worker rights” protests. She notified LB City Counsel of her intent to put together a labor protest in solidarity with the BLM movement. They in turn notified the PD and it made its way to me. She is holding the gathering at the Buddhist Monastery from 1200-1300 and expects anywhere from 50-100 people to attend.
