[REDACTED] called today to provide us with additional information. The mother of the suspect involved in his OIS was interviewed by Channel 7 news today and she labeled him a "killer cop." [REDACTED] stated she has done this before, however due to the current climate and the threats BLM has made to distribute flyers with his home address on it he is concerned. [REDACTED] is not staying in his home at this time, and is currently staying at a family's residence at [REDACTED]. [REDACTED] just wanted the troops to know, but I advised the WC and the DOC who wanted all of you included.

I was contacted by Chief [REDACTED] from Gardenia PD. He told me that several years ago, one of his officers was involved in an OIS in which the suspect died. The family is being represented by BLM and are currently suing the City. The Department was contacted by BLM and told that they were going to print up 100K flyers with the officers information on it. The Officer lives in our city. At this time there is no indication when/if this will occur. The Chief said the officer is concerned for his safety. At this point, Gardenia is not planning on putting any of their officers at the location, but is asking for our assistance with a DCC of the residence.

The officers name is [REDACTED] and his address is [REDACTED]. His cell # is [REDACTED]. Due to the hour, I have not contacted him.
