

The in-custody death of George Floyd, in the City of Minneapolis has sparked protests across the country. These protests have involved street and freeway takeovers that have resulted in injuries. In the City of Minneapolis and other major cities, there has been property destruction, looting, and fires. The losses to fires include the burning of a Minneapolis Police Station. The Department's plan for the protest is summarized below.
