Community Situational Awareness

- Curfew compliance
 - Minimal foot and vehicular traffic throughout the City
 - PEHs appear to be completely disregarding the curfew law
 - o 1600 hours is moderate minimal foot traffic
- It is quiet in the community with many businesses in the process of boarding up

Concerns

- False or misinformation online about protests, looting, crimes
 - This tactic was promoted online with the purpose to spread resources thin
- We have received multiple calls about possible locations/targets
 - Belmont Shore Have resources posted in the Shore and nothing now
 - "Hey Deon" Twitter user comment about targeting Belmont Shore appears to have been taken out of context.
 - o 7th Street / PCH No online evidence and UTL an event now
 - CSULB No online evidence and UTL an event now CSULB advised
 - VA notified of unverified info
 - Affluent neighborhoods
 - Residents with American flags
 - o "Blue Lives Challenge"
 - o Target "White People"
 - LASD Lakewood Station
 - LASD Intel notified by email
 - They have the same un-vetted info and thanked us

We are aware of several concerns circulating online regarding potential targets/locations to protest. We have been in contact with our regional and federal partners, who agree these are general unverified threats. These concerns are usually shared by a friend, by a friend, who received a text from their child's dentist. We will continue to assess but have not discovered anything to prove or disprove these threats.

- Curfew related post
 - LONG BEACH HAS SET A 1 PM CURFEW I just got this and it's almost 1:40 PM. STOP MAKING IT LEGAL FOR LAW ENFORCEMENT TO TARGET PEOPLE IN BROAD DAYLIGHT, THIS ISNT OKAY
 - #LongBeach sends out emergency alert for a *1:00PM* curfew at *1:26PM*. This sure looks like a pretext for excusing police violence, @LongBeachMayor
- African American man shot and killed by Louisville, KY police and Nat'l Guard during protest early this morning. (victim was a good protestor not a looter)
- People upset about the closing of COVID testing centers, saying the Mayor's punishing the city for protesting.
 - "The City of #LongBeach is punishing the community for protesting by closing #COVID19 testing sites."
 - "This is collective punishment. The City shutdown COVID testing & LB busses to collectively punish the people for protesting LBPD. The looting (that LBPD failed to respond to because they were busy shooting rubber bullets at protestors blocks away) is a just an excuse for it"
- Mood has changed since COP's news briefing
 - Lots of negative comments about the COP, LBPD, our officers, tactics from last night (or lack of)
 - These negative comments started as soon as the COP finished his press conference
 - People are being very critical of what the COP said and kind of angry
- Bad optics Picture of officer pointing 40mm at a child (bad angle but getting bad PR) Pic is in share folder
- Numerous re-posts of news media footage showing lack of PD response
- Minimal online activity (it's early)
 - Some negative comments/posts directed at looters
 - o Comments about the community coming together and cleaning up
 - Some negative comments, indicating cleaning up is more important than fixing police brutality/racism
 - Negative comments regarding PD response last night
- Per LASD:
 - "In the posts themselves and the comments attached, individuals are encouraging rioters and each other to target, attack, and loot predominantly white, upper-class/affluent neighborhoods and communities"

Partner Contact This Morning

- LASD Found an online threat by possible Long Beach resident
 - We ID'ed the subject and coordinating with Violent Crimes who is lead.
 - Unconfirmed if an actual crime has occurred
 - Being actively vetted
- FBI NSTR but info is forthcoming from analysts assigned to CP

Last Night's Observations (not all inclusive)

- Vehicles dropping of several subjects to commit crimes. Vehicle then leaves the location.
- Suspect lookouts observe officers responding in multiple vehicles and advise looters.
- When looting occurs, it appears subjects are possibly communicating via phones or phone apps. Do to the influx of people to the target location.
- Alternative methods for responding units could be the use of UC cars.
- Mob like mentality from the looters. One goes into a location and everyone else follows.
- Protestors attempted to stop subjects from looting and vandalism but were over run by the crowd.
- Once a location is cleared by PD, subjects returned to take more items from the location.
- Some groups of looters were traveling in caravans.
- Looters would stand on sidewalk and watch SWAT team drive by and then break into locations/loot
- Multiple times SWAT and response teams (12-16 vehicles) would pass looting to respond to a location (obviously, the team was dispatched) that was empty by the time they got there. (empowered looters they drove pass)
- Did not appear curfew was enforced.
- As the night went on and looting progressed northbound, it was heavily concentrated on Long Beach Blvd. (We drove from memorial Hosp to 7th St before seeing the first LB unit. We saw a school police vehicle patrolling the area).
- Looters were rolling 4 to a car and doing smash and grabs. (too fast for the tactics we deployed, no t-stops observed and these guys were driving "crazy")
- We observed LASD doing their version of smash and grab. They were driving down LBB and just grabbing people up to no good
- It appeared looting scenes were treated like a traditional crime scene versus an urgency to clear and move on to the next scene.
- Too much lag time between UC observations and response by strike teams. There's a need for communication plan. (UC's cannot always just park and direct units in, safety issue).
