Long Beach and Neighboring Cities' Events

- **Long Beach - Parkcrest – Peaceful Protest Against Police Brutality**
 - 1130 hours
 - [REDACTED] E. Parkcrest (Heartwell Park)
 - Concluded
- **Bellflower – Black Lives Matter Peaceful Protest**
 - 1300 hours (set up at 1230 hours)
 - [REDACTED] Flower St, Bellflower (Bellflower Library)
 - This event was located on Twitter
 - City of Bellflower put out advisory to business owners
- **Los Alamitos – Black Lives Matter Peaceful Protest**
 - 1430 – 1730 hours
 - [REDACTED] W Cerritos Los Al HS)
 - This event was schedule for June 2 but was re-scheduled for June 3
 - Small group showed up yesterday (peaceful)
 - Should expect more today
- **Long Beach – Black Lives Matter Peace & Meditation Sit In**
 - 1530-1730 hours
 - Bluff Park (Yoga Park? Exact location in park not identified)
 - This event is being shared on multiple social media platforms
 - Promoted as peaceful (yoga people organizing the event)
 - Ongoing, currently no issues

 - This event was located on Twitter

- **Yoga for Peace**
 - 1100 hours
 - Ocean / Junipero (Yoga Park)
 - Peaceful and Yogacentric

- Anti-Police Brutality Protest
 - 1700 hours
 - Harvey Milk Promenade Park
 - “Please wear face coverings & masks. This is a peaceful assembly to say that Black Lives Matter!”
 - Shared on Twitter and Facebook
 - AnarchistLB states they were asked to share the info, but no word on who is organizing it at this time
 - DSA-LB states it’s a “verified protest by Long Beach community members”
- Houghton Park BLM Ceremony
 - 1200 hours
 - Someone reposted the event and stated 1000 hours (prob a typo)
 - Houghton Park (NFD)
 - [REDACTED] (organizer)
 - Started a petition (as of 6/3, 0800 – 500 supporters)
 - Focus is to “...protest, clean up our streets, and donate to small business owners...on behalf of some community members and Jordan High School students...sign the petition...come out to Houghton Park.”
- CFA Action Against Police Violence, Racism, and the Murder of George Floyd (bring a sign and wear regalia!)
 - 1600-1700 hours
 - CSULB 7th Street entrance (we will gather together on the sidewalk near the corner of 7th Street and W. Campus Drive)
 - California Faculty Association sent an email regarding their family friendly protest
 - RSVP to [REDACTED] This will help with a headcount to help with social distancing plans.
 - CSULB and VA Hospital are aware

Concerns

- Continuously assessing tweets regarding LB Mayor and will provide assessments once vetted
 - Protesting outside mayors' residences is something occurring locally and nationally
- Continued tactic of false reporting of events
- Located a post referencing a drop off location in LB for supplies – vetted
 - Location is in the area of 4th / Walnut
 - Located a sign stating free, take what you want: a bag of water was at the location
