

Intel Brief - Thursday, June 4, 2020 (1800 hours)

Long Beach and Neighboring Cities' Events

Thursday

- Long Beach Faith Leaders Gathering: Calling for Prayer, Peace and Unity
 - [REDACTED] E. 7th St. (St. Luke's Episcopal Church)
 - 1000-1100 hours
 - This event was emailed to Chief Luna
 - Event is for leaders of faith communities only
 - Invite only, limited to 100
 - Media invited to share with public
- Sit In: Long Beach City Hall
 - 1530-1730 hours
 - 411 W Ocean
 - On Twitter with increased circulation and Instagram
 - No "organizations or groups" promoting this event
 - City Hall will be closed - per City Manager
 - No intel to indicate group will march to Mayor's residence
 - Port/CH cameras, multiple angles
 - Subject from yesterday stated, "same time tomorrow"
 - Assume this is referring to today's event
 - Very positive and recommend the Mayor speak again

Friday

- Pine Ave - Media Event: Mayor Garcia/Councilwoman Zendejas
 - 1045 hours (Council meeting at 1115 hours)
 - Due to time constraints, will be on scene 10-15 minutes
 - 7th St / Pine Ave
 - Photo Op, no presentation
 - Like all media events, this was blasted out to the media universe
 - As of 0900 hours, nothing seen online
- Bluff Park - Yoga for Peace
 - 1100 hours
 - Ocean / Junipero (Yoga Park)
 - Limited circulation on Twitter
 - Peaceful and Yogacentric
 - Some negative comments about organizer using current environment to promote yoga business

- Houghton Park BLM Ceremony
 - 1200 hours
 - Someone reposted the event and stated 1000 hours (prob a typo)
 - Houghton Park (NFD)
 - Joselyn Montano (organizer)
 - Started a petition (as of 6/3, 0800 – 500 supporters)
 - Focus is to “...protest, clean up our streets, and donate to small business owners...on behalf of some community members and Jordan High School students...sign the petition...come out to Houghton Park.”
 - At this time, limited circulation on Twitter (but 500 people have signed the petition)
 - Petition is on Change.org (so, unknown where 500 supporters live, could be international people)
- LBCC - Something Great Protest
 - 1200 hours
 - [REDACTED] E Carson (LBCC-LAC)
 - Shared on Next Door App, Twitter, and Instagram (increased circulation and being promoted)
 - Plan to meet at the bridge that connects over Carson
 - Plan to march northbound Clark to LASD Lakewood Station
 - Organizer stated they should be back at the campus by 1530 hours
 - Per organizer's Instagram:
 - *“We want to be as PEACEFUL as possible but yet heard...no violence, no vandalism, no looting or anything destructive please and thank you”*
- 2nd Street - Black Lives Matter Sit In
 - 1300 – 1700 hours
 - “Naples Bridge on 2nd Street” (NFD, but probably 2nd St / Bayshore)
 - “Youth” organized
 - Organized as a peaceful sit-in
 - We do not have anything else (nope, nada, zip, zero)
- CSULB - CFA Action Against Police Violence, Racism, and the Murder of George
 - 1600-1700 hours
 - CSULB - 7th Street / W. Campus Drive (on the sidewalk)
 - Organized by California Faculty Association
 - CSULB and CSUDH teachers
 - No students
 - CSULB Police and the VA Hospital are aware
 - No social media content at this time
 - Supported by CSULB Administration

- Harvey Milk Park - Anti-Police Brutality Protest
 - 1700 hours
 - Harvey Milk Promenade Park
 - Shared on Twitter and Facebook (increased circulation)
 - Shared/promoted by DSA, PRP, Anarchist Collective but not organizers
 - AnarchistLB states they were asked to share the info, but no word on who is organizing it at this time
 - DSA-LB states it's a "verified protest by Long Beach community members"

Saturday

- Caravan 4 Justice – Car Protest
 - 1300 hours
 - 5400 E. Ocean Blvd.
 - "Meet at the Beach Parking Lot"
 - Flyer received at "Long Beach Sit In" protest on Friday

Concerns

- George Floyd Funeral is today at 1100 hours (local time)
 - 8:46 minutes of silence
 - Promoted by NAACP
 - Unknown if anything locally organized in support
- Memorial Services for George Floyd are being planned nationally
 - Starting Saturday
 - Nothing located locally as of 0900 hours
- Assessing Mayor and his residence as targets for protests
 - Protesting outside mayors' residences is occurring locally and nationally
 - Numerous derogatory comments about the Mayor's leadership but no threats or indication he is being targeted
- Located a post referencing a drop off location in LB for supplies
 - Area of 5th /Walnut
 - This has been vetted - unfounded
 - Neighborhood store, "take something, leave something" water, TP, and snacks at site.
 - Location was checked numerous times throughout the yesterday
 - Will continue to assess
