

Intel Brief - Friday, June 5, 2020 (1300 hours)

Long Beach and Neighboring Cities' Events

Friday

- **Adventists for BLM Community Walk (CIS)**
 - 0830-1200
 - [REDACTED] E 3rd St (Seventh Day Adventist Church)
 - Plan to break up into groups and walk the neighborhoods/business districts
 - Minimal attention (low impact)
- **PCH / MLK – Community and Peace Walk (CIS)**
 - 1000-1200 hours
 - Corner (NFD) of PCH/MLK
 - Long Beach Alliance of Churches Prayer and community walk
 - Goal is to engage the community (per the info sent to us)
 - No indication this is being shared on social media
- **Pine Ave - Media Event: Mayor Garcia/Councilwoman Zendejas (CIS)**
 - 1045 hours (Council meeting at 1115 hours)
 - Due to time constraints, will be on scene 10-15 minutes
 - 7th St / Pine Ave
 - Photo Op, no presentation
 - Blasted out to the media universe...as of 0900 hours, nothing seen online
- **Bluff Park - Yoga for Peace (CCAT)**
 - 1100 hours
 - Ocean / Junipero (Yoga Park)
 - Limited circulation on Twitter
 - Peaceful and Yogacentric
 - Negative comments about using current environment to promote yoga
- **Houghton Park BLM Ceremony (NARCO)**
 - 1200 hours (reposted as 1000 hours but prob a typo)
 - Houghton Park (NFD)
 - Joselyn Montano (organizer)
 - Started a petition (as of 6/5, 0700 – 1600 supporters)
 - Focus is to "...protest, clean up our streets, and donate to small business owners...on behalf of some community members and Jordan High School students...sign the petition...come out to Houghton Park."
 - Limited circulation on Twitter (but 1600 have signed the petition)
 - Petition is on Change.org (so, unknown where 1600 supporters live, could be international people)

- **LBCC - Something Great Protest (CIS and CCAT)**
 - 1200 hours
 - [REDACTED] E Carson (LBCC-LAC)
 - Shared on Next Door App, Twitter, and Instagram (increased circulation and being promoted)
 - Plan to meet at the bridge that connects over Carson
 - Plan to march northbound Clark to LASD Lakewood Station
 - Organizer stated they should be back at the campus by 1530 hours
 - Being promoted by DSA as “Happening Friday before the Downtown Long Beach Protest”
 - Per organizer’s Instagram:
 - *“We want to be as PEACEFUL as possible but yet heard...no violence, no vandalism, no looting or anything destructive please and thank you”*
- **2nd Street - Black Lives Matter Sit In (NARCO)**
 - 1300 – 1700 hours
 - “Naples Bridge on 2nd Street” (NFD, but probably 2nd St / Bayshore)
 - “Youth” organized on Next Door App (community based)
 - Organized as a peaceful sit-in
 - We do not have anything else (nope, nada, zip, zero)
- **CSULB - CFA Against Police Violence, Racism, Murder of George (CIS)**
 - 1600-1700 hours
 - CSULB - 7th Street / W. Campus Drive (on the sidewalk)
 - Organized by California Faculty Association
 - CSULB and CSUDH teachers
 - No students
 - CSULB Police and the VA Hospital are aware
 - No social media content at this time
 - Supported by CSULB Administration
- **Harvey Milk Park - Anti-Police Brutality Protest (CIS and CCAT)**
 - 1700 hours
 - Harvey Milk Promenade Park
 - Shared on Twitter, Facebook, and Instagram (increased circulation)
 - Shared/promoted by BLM, DSA, PRP, Anarchist Collective and the DLBA, but not organizers
 - AnarchistLB states they were asked to share the info, but no word on who is organizing it at this time
 - DSA-LB states it’s a “verified protest by Long Beach community members”
 - Planning to march

 - “Meet at the Beach Parking Lot”
 - Flyer received at “Long Beach Sit In” protest on Friday
 - Promoted on Instagram and **Next Door App**
- **Signal Hill – Peaceful Protest Against Police Brutality**
 - 1500 hours
 - [REDACTED] Cherry Ave (Signal Hill Park, Cherry/Hill)
 - NFD

Concerns

- During City Hall rally yesterday, event organizers announced they will be “taking it to where the racist are in Huntington Beach.”
 - “12 noon at the pier.” Saturday AND Sunday.
 - Sounded like they were expecting a confrontation with MAGA people who have been demonstrating there.
 - One event found for 1100 on Saturday
 - Posted on MAGA supporter Facebook page
 - Several responses with inflammatory language
 - No further details listed on flyer (unable to determine legitimacy of flyer)
 - **HBPD aware of events and planning accordingly**
- Per LASD’s last SITREP from yesterday at 1900 hours, they are unaware of any events in LASD or LAPD’s AOR today (NOT GOOD)
 - This may change once they put out this morning’s SITREP
- Picture of officer with his baton and blood
 - Starting to trend on Social media and mainstream media
 - Could cause attendance to increase
- Online campaign on the east coast to “defeat” law enforcement:
 - Paraphrased: They are working 12 hour days with no days off. Protest everyday day to keep them busy and wear them out. No indication of violence. Same concept we heard yesterday, defeat them at the polls and vote.
- Memorial Services for George Floyd are being planned nationally
 - Starting Saturday
 - Nothing located locally as of 1300 hours
