This Training satisfies Senate Bill 29 (SB29) requiring all Field Training Officers (FTO's) to have at least 8 hours of crisis intervention behavioral health training.

Law enforcement officers are frequently called upon to manage incidents involving people with mental illness. This interactive training will cover mental illness, stigma, substance use disorders, developmental disabilities and more. The class will also feature a guest speaker, someone living with a mental illness who will share his experiences of living with a mental illness.

The Final Report of the President's Task Force on 21<sup>st</sup> Century Policing ([http://www.cops.usdoj.gov/pdf/taskforce/taskforce\\_finalreport.pdf](http://www.cops.usdoj.gov/pdf/taskforce/taskforce_finalreport.pdf)) was released in May of 2015. The report offers recommendations on how policing practices can promote effective crime reduction while building public trust. The recommendations and associated action items are organized in six main topics labeled in the report as "pillars." Pillar 5 addresses law enforcement training and states that more and better training is needed in specific areas in order to effectively handle contemporary law enforcement challenges.

As a result, in part, of the Pillar 5 findings, city funding has been earmarked this fiscal year to enhance officer training in the following areas:

- Community Policing and Problem Solving
- Interpersonal and Communication Skills
- Bias Awareness
- Scenario Based, Situational Decision Making
- Crisis Intervention
- Mental Health

Employees interested in training in these areas are strongly encouraged to apply for local courses that do not require an overnight stay. Training requests for courses in these topics should be submitted utilizing existing departmental training request procedures, along with a copy of this Watch Report. Please keep the Index Code box on the 3-page training request form blank.

Callback overtime is authorized to meet minimum staffing requirements associated with the absence of an officer attending training in one of the above topics. Officers working a callback shall use their regular Division index code and User Code "PDTR01."



