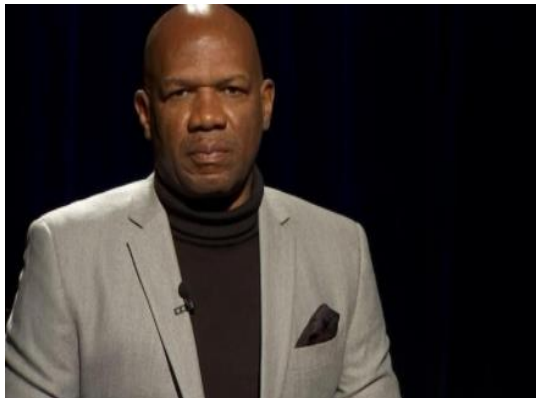

Police credit ShotSpotter in helping solve recent case, saving a gunshot victim

Springfield police say their ShotSpotter technology is helping them get to shooting scenes faster and solve the crimes.

It's just one part of the technology system they're using to help reduce gun violence in the capital city. Department leaders commended the technology to the city council on Tuesday.

Chief Kenny Winslow told the council that **he feels ShotSpotter is working for our community, especially with the shortage of police officers.**

Officers arrived at the scene just over two minutes after the alert came in. Police were able to obtain suspect information including a vehicle description within four minutes.

"Rather than a phone call from a citizen, where they say, 'It sounds like it came from down the block, or west of my residence,' the ShotSpotter system takes our officer directly to it," (Deputy Chief Joshua) Stuenkel said.

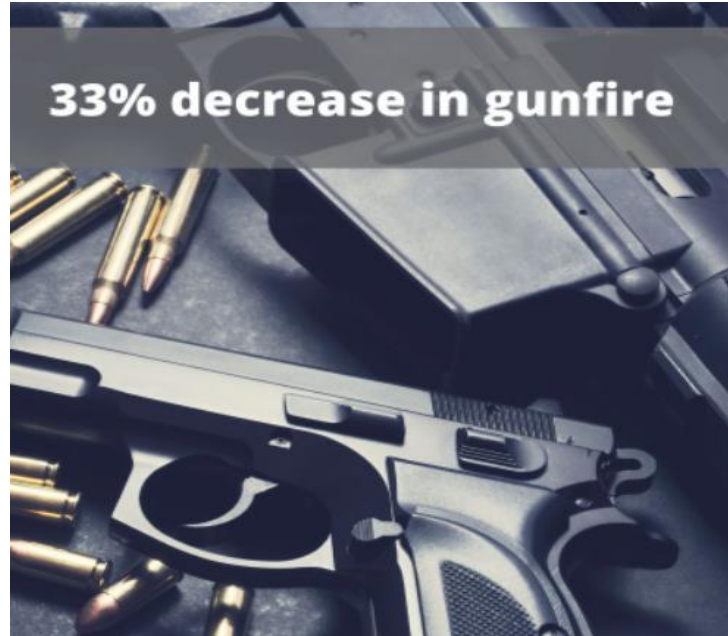

- Detailed Forensic Reports (DFR) support trial attorneys with court-admissible analysis of a shooting incident produced by forensic engineers, including audio of the gunfire. This can aid in the corroboration or discrediting of other evidence.
- Forensic engineers are available to provide expert witness testimony in support of a DFR.

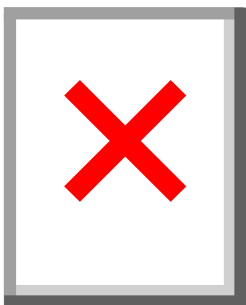

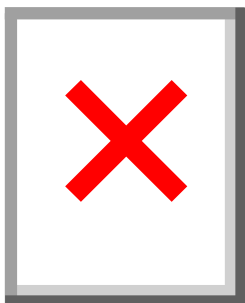
