This is a public records request to the Sarasota County Sheriff's Department. I do not know the case number, because it was never given to me. I was told the information in the case was sealed by detectives and I believe that I have a right to that information, and am therefore within the legal definition entitled, regardless as I believe that not all of it would be exempt from being made public and available to me.

I will provide relevant information to prove who I am, please see attachments.

Who I am: Kristian Brandon Nelson.

What I want:

This public records request would have to be centered around 911 phone calls placed to the county 911 line from the address 7000 Brentford Road, Sarasota Florida 34241, by myself (Kristian Brandon Nelson, age 8) to report the homicide of Kurt Cobain approximately between the hours 10:00am-11:00am on the morning of April 2, 1994.

I believe that the case is with the Sarasota County Sheriff's Department, and not with the County Clerk of Courts. I will be wanting all relevant information (paper works, audio file, and video, if applicable) which does not prove as exempt under Florida Statute. If provided with an estimate of cost, I would happily oblige to pay the fees associated with such a request.

"State has burden of showing that requested documents fall within the statutory requirements for exemption from disclosure under the public records act. *Lightbourne v. McCollum*, 969 So.2d 326 (2007), rehearing denied, certiorari denied 128 S.Ct. 2485, 553 U.S. 1059, 171 L.Ed.2d 777. Records key 65."

Hello Mr. Nelson, attached is a copy of your request. In regards to 911 call that you made , the retention period for the audio portion is only 60 days, and the reports documenting a 911 call was made is only available for 5 years. Any calls made in 1994 are no longer available. We show no calls for service or reports for the address of 7000 Brentford Road any time in 1994. If by chance you are talking about the death of rocker Kurt Cobain who died around this same time in Seattle Washington, the Sarasota County Sheriff's Office would have no information or reports on that investigation.
