The Chicago Police Department (CPD) is in receipt of your Freedom of Information Act (FOIA) request stating:

"To Whom It May Concern:Pursuant to the Illinois Freedom of Information Act., I hereby request the following records:Any and all contracts (as well as all associated amendments, exhibits, and materials), memorandums of understanding, and other equivalent agreements entered into by this agency with Cellebrite from 2016 to 2020. Responsive materials should include but not be limited to:

- the initial Invitation to Bid, Request for Proposal, or equivalent call for contractors
- the responsive materials provided by the winning bidder
- other bidder responses
- the current contract
- all exhibits
- all amendments
- all performance work statements
- all deliverables inventories
- all invoices related to the deliverance of software, services, or goods

The requested documents will be made available to the general public, and this request is not being made for commercial purposes. In the event that there are fees, I would be grateful if you would inform me of the total charges in advance of fulfilling my request. I would prefer the request filled electronically, by e-mail attachment if available or CD-ROM if not. Thank you in advance for your anticipated cooperation in this matter. Your request has been reviewed by the undersigned. The request is being *partially granted* pursuant to the below provision and including the attached as the responsive record. After searching the CPD database for this information, no responsive of records were found for

- the initial Invitation to Bid, Request for Proposal, or equivalent call for contractors
- the responsive materials provided by the winning bidder
- other bidder responses
- the current contract
- all exhibits
- all amendments
- all performance work statements
- all deliverables inventories

However, we are providing you with the invoices with redactions with all invoices related to the deliverance of software, services, or goods

Redactions and Exemptions:

Regarding the granted records, certain information is exempt from disclosure, and has been redacted accordingly. FOIA exempts the release of "[p]rivate information, unless disclosure is required by another provision of this Act, a State or federal law or a court order." 5 ILCS 140/7(1)(b). Private information is defined as:

[U]nique identifiers, including a person's social security number, driver's license number, employee identification number, biometric identifiers, personal financial information, passwords or other access codes, medical records, home or personal telephone numbers, and personal email addresses. Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person. 5 ILCS 140/2(c-5).

Any unique identification numbers like sales order number, invoice number and fulfillment number contained in these records, are private information and have been properly redacted pursuant to Section 7(1)(b).

The names, addresses, and other information that could be used to identify the complainant or witness or others who provided information to the police have been redacted. The redacted information is exempt from disclosure under 5 ILCS 140/7 (1)(d)(iv), which enables a public body to redact information that would:

unavoidably disclose the identity of a confidential source, confidential information furnished only by the confidential source, or persons who file complaints with or provide information to administrative, investigative, law enforcement, or penal agencies; except that the identities of witnesses to traffic accidents, traffic accident reports, and rescue reports shall be provided by agencies of local government, except when disclosure would interfere with an active criminal investigation conducted by the agency that is the recipient of the request.

You have a right of review by the Illinois Attorney General's Public Access Counselor (PAC). If you choose to file a Request for Review with the PAC, you must do so within 60 calendar days of the date of a denial letter. 5 ILCS 140-9.5(a). When filing a Request for Review, you must include a copy of the original FOIA request and <u>a denial letter</u>. You may also seek judicial review of a denial under 5 ILCS 140/11 by filing a lawsuit in the State Circuit Court.
