My name is Amanda Sanders with the Texas Attorney General's Office. I wanted to follow up from George's emails and provide you with more information about human trafficking in Texas and our agency's work to fight it.

In 2016, Attorney General Paxton formed the Human Trafficking and Transnational/Organized Crime Section (HTTOC) to combat human trafficking in our state. As you may know, Texas is estimated as 2nd in the nation for the most amount of trafficking victims, with more than 300,000 in the state, and 79,000 of them are child sex-trafficking victims. Our unit's efforts have led to significant victories, including a coordinated effort to shut down Backpage.com, which was the largest online trafficking website in the world. We've been able to prosecute and secure major sentences for traffickers, and assist victims in getting the resources they need. Our office leads the statewide Texas Human Trafficking Prevention Task Force, comprised of state agencies, law enforcement, and statewide victim service groups.

Our <u>Be The One In The Fight Against Human Trafficking</u> training video has been viewed in nearly every state, 76 countries, by thousands of people worldwide. Our agency, the Governor's office, and many other state agencies have used "Be The One" as a required training for all staff on human trafficking. Here is the link to the <u>trailer for the training video</u>. Earlier this year, our office worked with the University of Texas and Matthew McConaughey to produce the powerful <u>End Human Trafficking in Texas PSA</u>.

We look forward to possibly meeting with you and your staff on Friday, November 16 at the White House to discuss how we can combat human trafficking from a national level.
